

Washington, D.C. — **April 9, 2021** — With the <u>initial details</u> of the President's FY22 budget now <u>released</u>, the <u>Large Countywide and Suburban District Consortium</u> — a network of nineteen of the nation's largest and most highly-regarded school districts spanning twelve states from Washington to Florida — applauds the administration's deep commitment to public education. This commitment is particularly important this year as the Covid-19 pandemic continues to create unprecedented challenges for school districts and their students, staff, and communities.

The President's FY22 discretionary funding request would build on the historic investments of the American Rescue Plan Act of 2021 and bolster the ability of school districts nationwide to meet students' academic, social, emotional, and mental health needs, especially the increased needs of students disproportionately impacted by the pandemic and economic crisis. In the first three months of the new administration, President Biden and U.S. Education Secretary Cardona have affirmed commitments to ensuring that districts have the resources to respond effectively and equitably to both immediate and long-term needs. In addition to critical investments in domestic programs that support children and families beyond the PK-12 school setting, the President's FY22 request would more than double the 2021 budget for high-poverty schools through Title I grants. Additional funding increases targeted for students with disabilities and the mental health needs of all children more broadly will be an important lifeline for district support and innovation during this critical year of recovery and acceleration.

"President Biden's FY22 initial budget request sends a strong signal about the value we place in the next generation of Americans. Robust federal investments in education allow superintendents and educators to do more of what we know works for children and their families, particularly those who have been most adversely affected by the pandemic," said Consortium Chair Jack Smith, Superintendent of Montgomery County Public Schools (MD).

Cathy Moore, Consortium Vice-Chair and Superintendent of the Wake County Public School System (NC), echoed Dr. Smith's support, stating that, "Federal support for public schools is more important now than ever, as school districts seek to leverage the current moment for reducing historical inequities and build even stronger local education systems than we had before the pandemic."

The Consortium also appreciates the President's inclusion of school construction and broadband access as priorities of the administration's recent infrastructure proposal, the American Jobs Plan, a move that will enhance districts' capacity to safely reopen schools while also helping ensure all students can continue to learn during any future disruptions to in-person instruction.

The Consortium strongly supports President Biden's FY22 discretionary funding request, and looks forward to working with Secretary Cardona to ensure the prompt, planful, and equity-oriented implementation of all federal resources.
